HERE IS LETTER FROM DR SANKARAN PROVIDING MORE DETAIL AND BACKGROUND ON THE COURSE

Dear Colleagues and friends,

This is to introduce you to the Simplicity of Homeopathy webinars for 2021/2022. With this course we wish to impart the knowledge and practical skills which I have picked up in my 45 years of practice and teaching. However, that being said, 16 sessions are not enough to fit in 45 years of experience. Therefore, we have split these sessions apart to give participants enough time in between for self-study and to go over the all the coursework and all the further resources which we wish to share with you and ask you to make the most of. This certainly requires dedication, time and hard work but we will not ask anything of participants which we are not willing to do ourselves and as such will be with the participants throughout this period to answer any doubts and give guidance wherever it may be required.

As the course begins, before each session we will be timeously sending out the Cases which will be studied for that session. We ask the participants to go through the cases and to do their best to solve and analyse each case. By this we mean for you to find the centre of the case and the most important points. Please give your understanding of the case in terms of remedy prescription and understanding. Try to see if you can determine important features such as Miasm, Level of

experience, Kingdom and sub-kingdom classification. Keynote symptoms, repertorial analysis and other points should be sent for basis of prescription. We would also like you to suggest how you would proceed with the management of the case. We would request that you send this analysis the day before the session begins to the email address which will be provided. This is an important activity which we stress as it will help increase your familiarity with the subject matter and help you to recognise what mistakes you are making in your own analysis and understanding. Along with the cases, we will send recommended reference material in the form of videos, books and online content which will add to your understanding of the content to be covered in the session. This reference material will also be able to help you solve any doubts you may have after the session. If you still find yourself with queries we ask you to either raise them in the Q&A sessions or to send your questions to us so that we may either address them in private or include it in the next session for everyone's benefit.

The course will be presented in 3 components. The first component will be the Live Cases where I will do a live homeopathic case taking of a patient and then an analysis. Here participants can watch and then afterwards interact and discuss the case taking and analysis. The second component will be in the form of recorded lectures which will be sent out. These are some of our most prized content with cases and interactions demonstrating the latest in my approach and understanding of Homeopathy and Healing. These recordings will cover topics such as, Basics in homeopathy, Case taking and solving, the 8 Box Method, Kingdom overview, Mineral Kingdom, Animal Kingdom, Plant kingdom and using the Plant chart, Monocots vs Dicots, Subclasses and Superclasses and the WISE process. This content will also be highlighted and reviewed during the Live Case component. The final component will be live Q&A sessions with myself where participants can raise any queries which they have from the recordings or from any difficulties in which they are facing in their practices.

For the benefit of those who are joining us now in the second instalment of this series and who missed out on the first round we will be sharing a highlight course where for a reduced fee you will be able to watch the 5 most important session recordings so as to get a good understanding of the teachings which occurred and to be able to review the content. These recordings will be available for you to review for a period of two months.

After requests from participants, we have decided to record each session and make these recordings available for a fixed period after the session.
